**COVID-19 RESPONSE PLAN FOR RETURN OF LESSEES (Seasonal Non-Residents)**

**Cottage Season Opening date: June 9<sup>th</sup>, 2021**

**To**

**Cottage Season Closing date: October 11<sup>th</sup>, 2021**

**SAFETY PROTOCOLS:**

- **Wear a Mask (When interacting with Staff, Residents, other lessees or entering an establishment.)**
- **Wash Hands/ Sanitize (FREQUENTLY)**
- **Social Distance (When masks are not worn by 1 or more persons)**
- **No large gatherings!**

**\*ANYONE CAUGHT IN VIOLATION OF THE PROTOCOLS WILL FACE A PENALTY\***

- Beausoleil First Nation is preparing for the Cottage season to commence on June 9th, 2021. We will be sending out invitations prior to the opening date for our lessees to utilize our contactless software "Sine pro" when entering and exiting BFN Territory. This will alleviate the amount of paper copies being handled by staff and to expedite the processing time for each vehicle.
- For those who are unable to utilize the "Sine pro" software our Cottager form will be made available on our website, "[www.chimnissing.ca](http://www.chimnissing.ca)" please ensure that this form is completed prior to arrival at checkpoint 1.
- The medical screening form will also be available on the website for all lessees and their families. Please have this on hand either digitally or a physical completed before arrival.
- Prior to the season opening lessees will be required to provide updated information to the Beausoleil First Nation Lands & Resources Department as to the names and addresses of those IMMEDIATE FAMILY MEMBERS who were not listed last season - extended family and friends will not be permitted on Christian Island until further notice. The information gathered will be added to our database which will be provided to the Cedar Point screening/Security Staff.
- If a case of Covid-19 presents itself in the community (whether it is identified in the village or cottage areas), BFN will issue a "Stay at Home Order". This will require all residents and Cottagers to remain at their respective locations for a period of 48 hrs until contact tracing is completed. (Lands Staff will notify all lessees in the event of a positive case)

**No Travel Will be permitted during this time!**

- Travel Restrictions: Although, the BFN community members have unrestricted trips per week, we are advising Lessees that there will be a limit of 2 vehicles per cottage for opening and will be limited to 1 vehicle per cottage afterwards; Lessees are encouraged to limit their travels to Essential shopping, medical appointments and work.
- For the duration of the 2021 season Trailers with Boats, ATV's, Sea Doo's, etc., will Not be permitted to enter BFN Territory.
  - \* Lessees will however be able to remove these items from their cottage when leaving BFN Territory.
- Medical Screening: We will be activating a Self medical screening form on our website ([www.chimnissing.ca](http://www.chimnissing.ca)). Please have this form filled out prior to arrival, this form is automatically forwarded to the Lands Staff and Security team. A medical screening form must be completed for every occupant of the vehicle prior to arrival.
- Offices reopen: The Administration Building is open; however, we ask all non-residents to call in to the office and set up an appointment rather than attend in person for duration of the schedule identified above. Safety Protocols are to be adhered to.
- Non-essential businesses are open at 75% capacity, with employee & customer safety protocols in place.
  - \* Store Deliveries may be optional, please inquire with the proprietor of the establishment.
- With the exception of businesses operating under capacity restrictions, indoor gatherings of more than 10 are prohibited. (Safety protocols must be adhered to)
- Visitations with Residents: You must ensure that all safety protocols are adhered to at all times when visiting with residents.
- For contracted services (i.e., renovations, yard work, maintenance etc.) Follow safety protocols at all times. Please ensure that you and your families continue to follow the safety protocols of Masking, washing hands, Sanitizing and social distancing when interacting with others.
